Before commencing work or within a week after the date when the acceptance of the tender has been intimated to him, the probable value of contract which together with the amount of earnest money deposited shall be treated as security for the proper fulfillment of the same and shall execute an agreement for the work. If he fails to do this or maintain a specified in rate of progress (to be specified in each case in the tender schedule) the earnest money and security for the deposit shall be forfeited to Keralam Museum, fresh tenders shall be called for or the matter otherwise deposed off. If as a result of such measure due to the default of the tender to pay requisite deposit, sign contracts or take possession of the work any loss to Government results the same will be recovered from him as arrears of revenue, but should it be a saving to government the original contractor shall have no claim whatever to the difference. Recoveries on this or any other account will be made from the sum that may be due to the contractor on this or any other subsisting contracts or under the revenue recovery act or otherwise the Government may decide.

Now therefore these present witness and it is mutually agreed as follows:-

- 1. The terms and conditions for the said contract having been stipulated in the said tender form to which the contractor has agreed a copy of which is hereto appended which form part of this agreement it is agreed that the terms and conditions stipulated therin shall bind the partties to this agreement except to the extend to which they abrogated or altered by express terms and conditions herein agreed to and in which respect the express provisions herein shall supersede these of the said tender from.
- 2. The contractors hereby agree and undertaken to perform and fulfill all the operations and obligations connected with the execution of the said contract work.....

3. If the contractor does not come forward to execute the original agreement after the said work is awarded and selection notice issued in his favour or commits breach of any of the conditions of the contracts as quoted above within the period stipulated them, the government may re-arrange the work otherwise or get it done departmentally at the risk and cost of the contractor and the loss sustained by the Government can be realised from the contractor under the Revenue Recovery Act as if arrears of land revenue as assessed qualified and fixed by the adjudicating authority consisting of the Principal Secretary, Revenue, Archives Archaeology, Museum & Director, Archaeology/Archives/Museum & Executive Director Keralam Museum any other officer or officers authorised by the government in this behalf taking into consideration the prevailing DSR rates and after giving due notice to the contractor.

- 4. The contractor further agrees that any found due to the Government under or by virtue of this agreement shall be recoverable from the Consultant /Contractor from his EMD and his properties movable and immovable as arrears of land revenue under the provisions of the revenue recovery act for the time being in force or in any other manner as the Government may deem fit in this regard.
- 5. "The Contractor further assures that is clearly understood that the settlement of claims either by part bills or by final bills will be made only according to the availability of budget provision and allotment of funds made with the Executive Director, Keralam Museum under the respective heads of account in which the work sanctioned and arranged and also subject to the seniority of such bills. No claims for interest or damages whatsoever shall be made for the belated settlement of claims of bills.
