Pedestal

(The bidder is allowed to suggest the size and shape of the pedestal according to the proposed statue. They may also submit the drawing for the same at the time of bidding.)

Minimum basic requirements:-

Height: Approximately 6 ft

Structure : Concrete (approved by the structural engineer)

Surface: Stone claded or any other long lasting material which need not require maintenance.

INSTRUCTIONS TO THE BIDDER

The applicants are invited to submit their "Technical Proposal" i.e. details, stipulating to the eligibility criteria" and "Financial Proposal" in separate sealed covers for the requisite services.

The applicants must acquaint themselves to the nature of job, environment and factors / parameters prescribed.

EXPERIANCE

The bidder must have experience in casting Bronze statues in lost wax method. The bidder must submit the required details showing the complete infrastructure facilities, manpower, technical personnel, plant and machinery and equipments, number of years of experience in this field with the Technical Proposal. The bidder must submit list of the similar works executed. The certificate from the clients for satisfactory work and complete portfolio of the statues should also be enclosed with the Technical Proposal.

SUBMISSION OF BIDS

Technical Bid

Bidders must have their own fine art foundry and should have at least 10-12 years experience in the field of statue making in lost wax process. They must have an in house team of professionally qualified artists and technicians The technical bid and its evaluation will be based on the eligibility criteria as mentioned above and with due regard to the similar works undertaken in the past for Organizations as available, , Portfolio of the Company/ Artist, number of years of experience will be taken into consideration. The bidder must indicate the Financial turn over per year for the last 5 years, with conclusive proof. The client can visit the manufacturing facilities of the bidder and can also see statues being cast. The financial proposal of the bidder shall only be opened/ considered if the Technical Proposal found satisfactory.

The Financial Proposal should be a fixed "Lump Sum Amount" (in INR (Indian National Rupees) as cost of the statues payable by

The lump sum amount shall be submitted for -All services / submissions

The amount shall be inclusive of all taxes including service tax, duties, fees, levies and other charges imposed under the applicable law. The Bidder shall submit the financial proposal unconditionally.

SUBMISSION

The proposal shall be submitted in one separate sealed envelope scribed "Supply and installation of Mahatma Gandhi statue at Vaikam Satyagraha Smarakam" The parts shall include Part 1 - Technical Proposal and Part -2 Financial Proposal. The proposal shall be valid for a period of 45 days from the date of receipt of bid as indicated above.

The envelope shall clearly mention the Technical Proposal and Financial Proposal of the project.

The original proposal shall be prepared in indelible ink. It shall contain no interlineations or overwriting, except a necessary to correct any errors made by the applicant itself. Any such corrections must be initialled by the person or persons who sign(s) the proposals.

An authorized representative of the firm shall initial all pages of the proposal. The representative's authorization in original / notarized should be confirmed by a New Power of Attorney accompanying the Proposal.

EVALUATION OF PROPOSAL

The Technical Proposal of the Bidders would be evaluated as per following norms: -

TECHNICAL EVALUATION CRIETERIA

Technical Evaluation of the applicants would be carried out based on the following criteria: -· Portfolio of Bidder/ firm including details about studio set up, fine art foundry, work force, Space, Understanding about the lost wax method and patina techniques – satisfying the client. · Experience in the field of statue making with documentary evidence.

• Quality of the statues produced with documentary evidence.

· Financial turnover more than lakhs per year (average) for the last 5 financial years.

FINANCIAL EVALUATION

After the technical proposal is evaluated, the client will inform to those bidders whose proposals were considered non responsive to the RFP and also the bidders who have qualified the technical evaluation. Financial Proposal of the non responsive bidder shall be returned unopened after completing the selection process. The client will inform shall notify the bidder selected by the above process indicating the date and time for opening the financial proposal. The financial proposal shall be opened on the next day in presence of the bidder's representative who may choose to attend. The quoted amount shall be read and recorded. Applicants qualified in the Technical Evaluation shall be prequalified and short listed for Financial Evaluation. The Bidder quoted lowest shall be qualifying for issuance of letter of Intent, if all the other conditions are fulfilled entering in to the agreement with the Client.
